#### NASCAR POWERBALL PLAYOFF™ PROMOTION (2025)

#### **Entry Guidelines:**

- 1. Each Rhode Island Lottery Powerball® ticket purchased from 7:00 a.m. on Sunday, May 18, 2025, through 9:50 p.m. on Saturday, July 19, 2025 ("Promotional Period"), will include a Second Chance Code eligible for entry into the NASCAR Powerball® Playoff 2025 Promotion ("Promotion").
- 2. Only registered Rhode Island Lottery VIP Club members with Standard level and Plus level memberships ("VIP Members") are eligible to enter this Promotion. VIP Club registration is free, and individuals eighteen (18) years of age or older must visit https://www.rilot.com/en-us/registration.html or download the Rhode Island Lottery mobile app to create a VIP Club account. VIP Club members with a Lite level membership can upgrade their account to a Standard or Plus level membership by logging in to their account and clicking "Upgrade."
- 3. Eligible VIP Members will need to purchase a Powerball® ticket in Rhode Island during the Promotional Period and then log into their account and enter the twenty-three (23)-character Second Chance Code printed on the ticket in the Entry Box for this Promotion. Alternatively, eligible VIP Members can log into their account using the Rhode Island Lottery mobile app and scan the QR code from the front of the ticket to enter.
- 4. Each eligible entry will receive a corresponding number of entries into the Rhode Island Semi-Finalist Drawing for this Promotion. The number of entries a VIP Member will receive per Second Chance Code entered is dependent upon the dollar value of the Powerball® ticket purchased, i.e. a two-dollar (\$2) ticket will receive two (2) entries.
- 5. There is a Second Chance entry cap of one thousand entries per calendar month per VIP Member in total amongst any eligible Second Chance Promotions.

- 4. Any RI Semi-Finalist Winner who is also a winner in any Multi-State Drawing will be reviewed for debt owed to the State of Rhode Island. If such winner is identified as having an outstanding debt to a Rhode Island State Agency or child support collected through a court, the debt must be satisfied by such winner.

- Two (2) Official NASCAR Championship Weekend<sup>TM</sup> Event Programs;
- Two (2) Racing Electronics Scanner Rentals for use while at Phoenix Raceway;
- Two (2) Souvenir Gift Bags, each with a retail value of at least two hundred fifty dollars (\$250);
- All meals while in PHX; and
- Ground transportation to and from airports, hotel, and activities in PHX.

Finalists are not required to travel to PHX to participate in the drawing for, and remain eligible to win, the \$1 Million Prize. Finalists may appoint a proxy and provide contact information for the

proxy, on or before October 15, 2025, to take the trip instead, subject to the Trip Prize Terms and Conditions, but will still remain eligible to win the \$1 Million Prize.
